St. Peter's Lutheran Church Calls a New Minister

The two year long pastoral call process at St. Peter's Lutheran Church came to a joyous conclusion on Sunday, October 19, when the congregation voted to invite Pastor Christephor Gilbert to become our next minister. After a "meet and greet" on the preceding Saturday morning marked by a full parking lot and a constant line of folks waiting patiently to talk to Pastor Gilbert, followed by a Sunday worship service and sermon conducted by the candidate, the congregation held a special congregational meeting in the Sanctuary with just two agenda items:

- 1. A member vote on the following resolution posed by Chris Janson: "As Chair of the Pastoral Call Committee 2025, we offer a resolution that Christephor Gilbert be called as the next pastor of St. Peter's Lutheran Church."

 After brief discussion, the quorum of members present voted by written ballot to call Pastor Gilbert as our next pastor, having satisfied the 2/3 majority vote required.
- 2. Next, church treasurer Suzanne Bassett presented the compensation package which, after brief discussion, was approved by a majority of members present through a show of hands vote.

Pastor Gilbert was invited to return to the Sanctuary, and he briefly addressed a delighted congregation.

Let us all give thanks for Pastor Gilbert's call to us! Welcome, Christephor and Donald to St. Peter's family as we continue our journey together in the footsteps of Jesus.

Getting to know St. Peter's new Pastor, Pastor Christephor Gilbert



The Rev. Christephor Gilbert is a pastor, teacher, and creative spirit whose ministry is rooted in God's love, justice, and presence in community. Awakened by the call of the church, Christephor seeks to walk alongside others in faith, listening deeply and helping people discover how God is at work in their lives and in the world.

Originally from Louisville, Kentucky, Christephor received a Master of Divinity from the Lutheran School of Theology at Chicago, where formation included work with Extraordinary Lutheran Ministries, St. Paul's House, Bonaventure House, and Resurrection Lutheran Church. He also served at Faith Lutheran and Risen Savior Lutheran in Fort Wayne, Indiana, and St. Paul Lutheran in Arlington, Massachusetts, experiences that helped shape a pastoral identity grounded in compassion, justice, and accompaniment.

From 2019 to 2023, Christephor served as pastor to St. Ansgar Lutheran Church in Portland, Maine. During this time, he also served as secretary of the Maine Council of Churches and as a member and chaplain to the New England Synod Council of the ELCA. Before his call to St. Peter's, Christephor served Christ Lutheran Church in Natick, where he is an active member of the Natick Interfaith Leaders Group. Christephor is a certified facilitator of the Prepare/Enrich relationship assessment program and a Qualified Administrator of the Intercultural Development Inventory. Christephor's ministry is enriched by a diverse background. Before pastoral leadership, he worked in the performing arts as a choreographer, artistic director, and educator, holding a BA in Theatre and Dance from Bard College and an MFA in Dance from the University of Hawai'i. His studies also include a Master of Arts in Spirituality from Bellarmine University. This blend of theology and the arts continues to shape a ministry that embraces creativity, embodiment, and imagination.

Christephor's co-conspirators in life are his husband, Donald, and beloved cat Aeriel. Together they delight in community, hospitality, and exploring the many ways God's Spirit continues to move in the world.


Ministry Fair 2025



At 10 shared tables, representatives of over 20 ministries and volunteer groups were available to answer questions and sign up people interested in giving their time and talents to their areas. The displays of St. Peter's church mission work were rewarding to see. Almost 30 people signed up at the Fair to volunteer their time and talents to these groups. A highlight of the fair were Hole in One donuts (so large they had to be cut in half!) and cider provided by Worship Ministry. The Fall food basket was won by Lois Thomas. There was a "buzz" of fellowship heard in the room. It's not too late to volunteer at one of St. Peter's ministries. Below is a full list. Ministries Represented at the Ministry Fair:

- AMMPARO: the ELCA network of welcoming and sanctuary congregations
- Altar Care: Care for altar and Communion preparation

- Music Ministry/ Choir: lead church music including adult choir, worship, musicians, etc.
- · Office Help: assist with office tasks, help prepare bulk mailing
- Pastoral Care: provide spiritual and social support to congregation members

- Prayer Shawl Ministry: knit/crochet and give prayer shawls away for comfort, welcome, celebration
- **Property**: oversight of St. Peter's church land and property; sponsors volunteer work days; provides information for capital budget. Volunteers needed for Property ministry.
- PSALM (People Sharing and Loving More): outreach to women and children. Cranberry Fair is the major fundraising event.
- Sacred Sorrow: supports bereaved parents
- Safe Harbors: sponsors/supports immigrant family
- **Staff Support**: provides support to church staff, assists with hiring









St. Peter's Lutheran Church Protocol Regarding A Visit by ICE Agents

In the unlikely event that agents from ICE (Immigration and Customs Enforcement) attempt to enter St Peter's, the following protocol should be followed. The person who has initial contact with an agent should:

- A. Stay calm and be respectful.
 - 1. Be aware that agents can, like any other person, enter public areas with out a warrant (see below).
 - Ask for identification and the purpose of the visit.
- B. Ask if the agents have a warrant and ask which type of warrant.
 - 1. If they have an <u>administrative warrant</u>, they cannot enter private** areas (see below) without your consent. In general, <u>do not give consent</u>. Say, "This is a private area. You cannot enter without a judicial warrant."
 - ICE can arrest someone in a public* space if they have an administrative warrant.
 - 2. If they have a <u>judicial warrant</u> (i.e., signed by a judge), they can enter private areas and can arrest someone in such spaces.
- C. Do not give the agents any personal information regarding church staff or members, or food pantry visitors unless they provide a judicial warrant for that information. (Massachusetts privacy law requires that organizations which acquire client information keep those records secure and private. Food pantry customer identifying information is <u>not</u> kept at the church.)
- D. Stay with the Agent and as feasible, take notes.
- E. Contact the Pastor as soon as possible.

From the Tech Team- How to Access "the Loop"

St. Peter's sound system is equipped with a public hearing loop system. To use the public hearing loop system, you need to activate **the telecoil mode** on your hearing aid. A telecoil is a small coil of wire in most prescription hearing aids and cochlear implants. It creates a magnetic field to receive audio signals from an inductive loop system. This direct transmission of sound to your hearing aid significantly reduces background noise, leading to clearer sound. Telecoil can be accessed either via its app or by pressing a button on the device itself. All hearing aides are different so you may need to talk with your provider to make it work for your device. But here are some suggested approaches based on internet search.

On your iPhone:

Go to Settings > Accessibility > Hearing Devices.

Enable the "Hearing Aid Compatibility" setting to modify the phone's acoustic settings for telecoil mode.

On your Android device

Ensure your hearing aid is set to its "T" or telecoil mode.

Turn on the Hearing Aid Compatibility (HAC) mode in your device's settings. You may also use your manufacturer's specific app for more advanced control.

- A telecoil is a small coil of wire in most prescription hearing aids and cochlear implants.
- It creates a magnetic field to receive audio signals from an inductive loop system, such as those found in public venues or on some smartphones. This direct transmission of sound to your hearing aid significantly reduces background noise, leading to clearer sound.

Using the telecoil in public.

- **1. Activate the telecoil setting on your hearing aid:** You may need to do this through your smartphone's hearing aid app or a button on the hearing aid itself.
- **2. Listen for the loop:** Once activated, your hearing aid will receive sound directly from the loop system, which reduces background noise.

Cape Cod Council of Churches 2025 Annual Assembly

On September 25, Peg Flood and Jane Wordsworth attended the annual assembly of the Cape Cod Council of Churches held at Brewster Baptist Church as St. Peter's Representatives.

The meeting started with a half hour for registration, fellowship, and light food. A worship service followed which included blessing of the donations of food brought by attendees for the Hands of Hope Food Pantry, prayer, singing, scripture and a message about mutual care and sacred service. The Business Meeting chaired by Rev. Philomena Hare included the Treasurer's Report, voting to approve minutes and two minor amendments to bylaws, followed by election of the Board of Directors, Standing Committees, and Advisory Committee. Volunteers were blessed and thanked. Before the meeting was adjourned, Edye Nesmith noted that in 2025, 19,466 people were served by 387 volunteers comprising over 14,000 hours of service. There are 91 church partners and 90 community partners. She also mentioned a major fund raising effort being planned, a partnership with Snowy Owl Coffee to sell Council of Churches blend coffee later this fall, and an invitation for groups to contact the Council offices to arrange a tour of their new office at 232 Main Street, Hyannis which also houses A Baby Center, and Covenant to Care for Foster Families.

The Cape Cod Council of Churches includes the following programs:




The Spheroid Shape of the Earth

The Earth is an Oblate-Spheroid planet meaning it bulges at the equator and squashes at the poles. The diameter at the equator is 7,980 miles and 7,900 miles between poles. When the early molten Earth began rotating at super speeds, centrifugal forces caused the equator to bulge like it is today. Even the bulging of sea levels vary close to the equator.

Because of the Earths's bulge, the 20,949 foot Mount Chimborazo in Ecuador is higher than the 29,035 foot Mount Everest in Nepal. This fact is based on the distance the two mountains are from the center of the Earth. It's the bulge that makes the difference.

A person standing at the poles will weigh more than normal because the force of gravity is stronger. And if you stand on the equator, you will weigh less because there's more distance between you and the Earth's center. So, the Earth is not a perfect sphere as it would appear to be by most people!

First we thought the Earth was flat, then we thought it was a sphere, and today we know it is a spheroid sphere! God has always known about the shape of the Earth.
